FAO LOA to support National Consultations on ASEAN Master Plan on Rural Development-Family Farming and the Draft ASEAN Guidelines on AE Transition

> With supplemental grant from CIAT Bio Vision/AE Coalition

#### **Objectives of National AE Consultations**

- Socialize key ASEAN instruments the Master Plan on Rural Development and the Guidelines on Sustainable Agriculture – as starting points for building strategies and actions in support of food systems transformation through sustainable agriculture and agroecology transitions;
- Generate inputs from national stakeholders on the on-going effort to develop an ASEAN Guidelines on Agroecology Transitions
- to participate in shaping policy agenda and prProvide an inclusive space for family farmer organizations and civil society ogramming in support of their work at local and national levels; and
- 4. Catalyze potential multi-stakeholder partnerships and mechanisms needed to sustain the process of developing impactful plans and actions for SA and AE, and food systems transformation
